

eCatcher sets Tap-Win32 IP via NETSH or DHCP command

1. NETSH or DHCP

From version 3.0.1 until version 5.0 then starting again version 5.1, eCatcher uses a NETSH (network shell) command to set the VPN IP address of the Tap-Win32 adapter.

In other versions (prior to 3.0.1 and between 5.0 and 5.1) of eCatcher the IP address of the Tap-Win-32 adapter was attributed using DHCP by default.

The use of netsh is a more direct way to set the IP address than using the DHCP feature on the Tap-Win32 adapter.

But it might happen that on some PC configurations the netsh command fails. If such behavior should happen, eCatcher will display an error message.

2. Error Messages

Cannot connect to Talk2MServer: > FATAL: NETSH: command failed

or

Cannot connect to Talk2MServer:> FATAL:Error:When using --ip-win32 netsh, if you have more than one Tap-Win32 adapter, you must also specify -dev-node"

or

 ${\it VPN}$ tunnel error: Cannot assign IP address to TAP-Win32 adapter using NETSH

In these cases, to allow the VPN connection, you can change back to the IP address attribution mode using DHCP. To achieve this follow the steps listed hereunder:

- 1. Close the eCatcher application.
- 2. Open the "\Talk2mVpnService\conf\" folder of the directory where eCatcher is installed.


By default this should be "C:\Program Files (x86)\eCatcher-Talk2M\Talk2mVpnService\conf"

- 3. Open the "Talk2MClient.ovpn" file using notepad.
- 4. Replace the line "--ip-win32 netsh" with following 2 lines:
 - o dhcp-renew
 - o dhcp-release
- 5. Save the file.
- 6. Launch the eCatcher software.
